The northern side of the Fourth Avenue Building Sub-Basement consists mainly of parking spaces. There are a total of four ADA parking spots available as well as two sets of stairwells on each northern corner of the building. There are also two elevators located towards the northwest side of the building.

Restrooms

There are no restrooms on the southern side of the Lower Level. Restrooms can be accessed in the Central Lower Level.

Wheelchair Accessible Entrances and Exits

Wheelchair access to the Sub-Basement is made by elevator and can be accessed through the Lower Level.

Elevators

Two elevators are located on the northwest side of the building. Elevators E002-46 and E002-47 provide access to the Sub-Basement through the Lower Level.

Stairs

Stairwell S002-04 is located on the northeast corner of the parking and stairwell S002-06 is located on the northwest corner of the parking garage and both have access to the Sub-Basement through the Basement.

The southern side of the Fourth Avenue Building Sub-Basement consists mainly of parking spaces. There are no ADA parking spots available. There are as well as two sets of stairwells with the first one located towards the southwest side and the second one located towards the southeast corner of the Sub-Basement. The west side is also partially made up of mechanical space as well.

Restrooms

There are no restrooms on the southern side of the Lower Level. Restrooms can be accessed in the Central Lower Level.

Wheelchair Accessible Entrances and Exits

Wheelchair access to the Sub-Basement is made by elevator and can be accessed from the Lower Level.

Elevators

Both elevators are located on the northern side of the Sub-Basement.

Stairs

Stairwell S002-08 is located on the southwest side and stairwell S002-07 is located on the southeast side of the floor and has access to the Sub-Basement through the Lower Level.

The northern side of the Fourth Avenue Building Basement consists mainly of parking spaces. There are three ADA parking spots available. The area also has a stairwell on the northwest corner of the building and a stairwell on the northeast corner of the building. The Basement also has two elevators that are located towards the west side.

Restrooms

There are no restrooms on the southern side of the Lower Level. Restrooms can be accessed in the Central Lower Level.

Wheelchair Accessible Entrances and Exits

Wheelchair access to the Basement is made by elevator and can be accessed from the Lower Level.

Elevators

Two elevators are located on the northwest side of the building. Elevators E001-46 and E001-47 provide access to the Sub-Basement through the Lower level.

Stairs

Stairwell S001-04 is located on the northeast corner of the parking and stairwell S001-06 is located on the northwest corner of the parking garage and both have access to the Sub-Basement through the Basement.

The southern side of the Fourth Avenue Building Basement consists mainly of parking spaces. There are no ADA parking spots available. There are as well as two sets of stairwells with the first one located towards the southwest side and the second one located towards the southeast corner of the floor.

Restrooms

There are no restrooms on the southern side of the Lower Level. Restrooms can be accessed in the Central Lower Level.

Wheelchair Accessible Entrances and Exits

Wheelchair access to the Southern side of the Basement is made by elevator and can be accessed from the northern side of the Basement and the Lower Level.

Elevators

Both elevators are located on the northern side of the Basement.

Stairs

Stairwell S001-08 is located on the southwest side and stairwell S001-07 is located on the southeast side of the floor and has access to the Sub-Basement through the Lower Level.

On the northern side of the Lower Level in the Fourth Avenue Building, the elevators are located centrally in the building. The elevator lobby for elevators E000-49 and E000-50 is bordered to the north by corridor C000-04 that leads to suites 000-05, 000-04, and 000-10 heading east; and stairwell S000-02. The elevators are bordered to the west by corridor C000-05 that leads to suites 000-11, 000-13, 000-12, 050-08, 000-14, and 025-00 heading south.

Restrooms

Restrooms are located along corridors C000-02 and C000-03 just north of the elevators. 030-01 is the women's restroom located south and 030-06 is the men's restroom located north.

Wheelchair Accessible Entrances and Exits

Wheelchair entry into the building can be made via the Lower Level. Wheelchairs enter on SW Harrison St using the sidewalk and follow the pathway towards the elevators heading south.

Elevators

Two elevators are located centrally within the building just south of stairwell S000-02. Elevator E000-49 and E000-50 provide access to the Lower Level through Floor 2.

Stairs

Stairwell S000-01 is located just east of the main accessible entrance to the building on the north side. This stairwell has access to the Lower level through the Penthouse. Stairwell S000-02 is located just north of corridor C000-04. This stairwell has access to the Lower Level through Floor 2. Stairwell S000-03 is located towards the south end of corridor C000-05 and is just south of suite 000-14. This stairwell has access to the Lower Level through Floor 2.

On the central side of the Lower Level of the Fourth Avenue Building, the elevators are located centrally towards the west side of the building. The elevator lobby, L000-01, is bordered to the north by corridor C000-15 that leads to the all-gender restroom in 000-21, elevator E000-48 and suite 025-01 heading north; and both the men's and women's restrooms. The elevator lobby is bordered to the west by corridor C000-11 that leads to suites 070-04, 000-28, 089-01, and 089-02 heading south.

Restrooms

Restrooms are located just north of the lobby L000-01. 000-19 is the women's restroom located to the east and 000-20 is the men's restroom located west. Room 000-21 is an all-gender restroom.

Wheelchair Accessible Entrances and Exits

Wheelchair entry into the building can be made via the Lower Level. Wheelchairs enter on SW Harrison St using the sidewalk and follow the pathway towards the elevators heading south.

Elevators

Three elevators are located centrally towards the west side of the building. Elevators E000-46 and E000-47 provide access to the Sub-Basement through the Lower Level.

Stairs

Stairwells S000-04 and S000-04A are located towards the northeast side of the central part of the Lower Level. This stairwell is an exit to the nearby sidewalk. Stairwell S000-05 is located just east of the elevators and lobby. This stairwell has access to the Lower Level through the Plaza. Stairwell S000-06 is located within the mechanical space and is not accessible to the public.

On the southern side of the Lower Level of the Fourth Avenue Building, the elevators are located centrally within the building. The elevator lobby for elevators E000-68 and E000-69 are bordered to the west by stairwell S000-09 and lobby L080-09. The elevators are bordered to the east by suite 083and a major corridor C081-01. The south part of the building is mainly made up of mechanical space.

Restrooms

There are no restrooms on the southern side of the Lower Level. Restrooms can be accessed in the Central Lower Level.

Wheelchair Accessible Entrances and Exits

Wheelchair entry into the building can be made via the Lower Level. Wheelchairs enter on SW Harrison St using the sidewalk and follow the pathway towards the elevators heading south.

Elevators

Two elevators are located centrally within the building. Elevators E000-68 and E000-69 provide access to the Sub-Basement through the Lower Level and also provide access to the up to Floor 5 of the Engineering building.

Stairs

Stairwell S000-09 is located just west of the elevators E000-68 and E000-69 and Lobby L080-09. This stairwell has access to the Lower Level and Floor 5 of the Engineering Building. Stairwell S000-08 is located on the southwest side and stairwell S000-07 is located on the southeast side of the floor and has access to the Sub-Basement through the Lower Level.

On the Plaza Level of the Fourth Avenue Building, the elevators are located centrally in the building. The elevator Lobby for elevators E100-49 and E100-50 are bordered to the north by corridor C104-00 that leads to suite 175-00, the men's restroom in 103-00, and stairwells S100-02 heading east. The elevator lobby is bordered to the south by suite 170.

Restrooms

Restrooms are located just north of the elevators and lobby. The women's restroom is located along corridor C105-00 in room 101-00. The men's restroom is located along corridor C104-00 in room 103-00.

Wheelchair Accessible Entrances and Exits

TWheelchair access to the Plaza Level is made by elevator and can be accessed from the central side of the Lower Level.

Elevators

Two elevators are located central within the building just south of corridor C104-00 and stairwell S100-02. Elevators E100-49 and E100-50 provide access to the northern side of the Lower Level through Floor 2.

Stairs

Stairwell S100-01 is located on the north end of corridor C105-00. This stairwell has access to the Lower level through the Penthouse. Stairwell S100-02 is located just north of corridor C100-00. This stairwell has access to the Lower Level through Floor 2. Stairwell S100-03 is located towards the south end of the building and on the west side of corridor C170-01. This stairwell has access to the Lower Level through Floor 2.

On Floor 2 of the Fourth Avenue Building, the elevators are located centrally in the building. The elevator lobby L200 is bordered to the north by stairwell S202 and the men's restroom in 203. The elevator lobby is bordered to the south by suite 267 that is just east of corridor C203.

Restrooms

The women's restroom is located just south of corridor C200 and just west of vestibule V204 in room 201. The men's restroom is located along corridor C203 and is just north of elevators and lobby in room 203.

Wheelchair Accessible Entrances and Exits

Wheelchair access to Floor 2 is made by elevator and can be accessed from the northern side of the Lower Level.

Elevators

Two elevators are located centrally within the building. Elevators E100-49 and E100-50 provide access to the northern side of the Lower Level through Floor 2.

Stairs

Stairwell S201 is located on the north end of corridor C205 and just north of suite 295. This stairwell has access to the Lower level through the Penthouse. Stairwell S202 is located just north of lobby L200 and elevators. This stairwell has access to the Lower Level through Floor 2. Stairwell S203 is located towards the south end of the building and on the west side of corridor C203 and vestibule V23. This stairwell has access to the Lower Level through Floor 2.

The Fourth Avenue Building Penthouse is restricted access. It is reached by means of the central stairwell, S300-02, which ascends from Floor 2.

The Fourth Avenue Building Roof is restricted access and cannot be accessed by a public entrance.
