- MM- HB 2367
 - HB 2367 would end the criminalization of homelessness by establishing that people are legally not allowed to be harassed, arrested or cited for sitting, sleeping, or lying down in an unobstructive manner.
 - HB 3115 merely states that the laws used to harass, cite, and arrest people for conducting these survival activities must be reasonable.
 - JG- HB 2367- The bill was written in the spirit of the <u>Martin v. Boise ruling</u>, a 2018 U.S. 9th Circuit Court of Appeals decision that bans governments from criminalizing living in public spaces if the local government is not providing enough shelter beds for each homeless person.
 - JG- The City of Portland's <u>One Point of Contact Campsite Reporting System</u> is the mechanism community members can use to report issues of illegal camping or related garbage within Portland. Webpage contains other resources as well
