FEI \$2,000 Academic Award for Outstanding Scholarship

This year the Portland Chapter of Financial Executives International recognizes the outstanding scholastic achievement of a student majoring in accounting or finance by awarding six \$2,000 academic awards. Awards are granted to one student at each of the following schools: University of Oregon, Oregon State University, Portland State University, University of Portland and Washington State University Vancouver. An additional award is available to a student attending any university in Oregon or Southwest Washington.

The process for granting of the award is described below:

Student Eligibility/Requirements:

• Must have declared accounting or finance as a major

• Have accumulated at least 60 semester hours or 90 quarter hours (a junior) as of January 2023

- Have earned at least a 3.5 GPA on a 4.0 scale
- Expected to be enrolled as a full-time student during 2023-24 academic year

• Demonstrated financial need, this can be done via the student's personal statement • Exhibit personal qualities that will contribute to a professional career, upholding the standards of Financial Executives International

• Be able to articulate the merits of a professional career in finance or accounting from their own perspective

Demonstrate outstanding desire, ability and achievement in all academic endeavors, as well as leadership and character in extracurricular activities
Submit a written **personal statement** that addresses the items above, including a copy of their most current university transcript and contact information (e-mail, home address and phone number).

Additional Requirements:

• Submit an unofficial transcript with your application

• Provide two letters of recommendation, with at least one being a faculty member at the student's current university on university letterhead

• Provide **personal statement**, transcripts, letters of recommendation and confirmation that University personnel verified eligibility by March 6, 2023 to

Selection by FEI:

• FEI reserves the right to accept or reject any application submitted in accordance with the above

• FEI makes the final determination of award winners

• Such determination will be made by the Chair of the Academic Relations Committee of the Portland Chapter, together with at least one other member of the committee • Selection committee will designate an alternate recipient in the event of student transfer or other disqualification, between the time of the original selection and the time of the actual award

• An official transcript for the selected winner must be provided upon notification of the award and prior to receipt of the monetary award. FEI reserves the right to disqualify the selected student if an official transcript is not provided within 45 days of the award notification.
