Old Action Items and Safety Concerns

- CQ What's happening with the out-of-order Cramer elevator?
 - JP The elevator still has out-of-order stickers on it after over a month, and the current status of the issue is unknown. JP will
 contact the people involved and update the committee.
- JH Some people have recently stated that the PSU Bookstore in Urban is now being controlled by PSU instead of Barnes and Noble. Is this accurate?
 - o JR Will speak to Laverne about a possible tenant change, but currently believes this is not true.
 - Some of the backend maintenance has been shifted to FPM, but the ownership remains with Barnes and Noble.

Rounds / New Safety Concerns

- AB Work order system
 - Any work taking place outside is automatically sent to Landscaping. Contact the Work Control Center for some jobs, such as outdoor window cleaning, that is outside the scope of Landscaping. The WCC will also have quicker response times for urgent requests.

 - Buildings that are grayed out on campus maps are outside of PSU's responsibility, and work orders should not be made for these spaces. If you aren't sure, consult the map first.

- The front door cracked at Urban what is the timeline for repairs?
 - JP This is not a security or safety issue as this was specialized security glass, and the door is still operational. This is expected to not be fully repaired until around December, but a temporary door will be installed in several weeks.
- There are many cases of Covid going around. Are there any protocols in place?
 - JR There are still wipes, masks, and hand sanitizer for request at Materials Management. Cases are rising nationally, so please continue to be mindful of your health, mask as necessary, wash your hands often, etc. HEPA filters are still deployed across campus, and you can contact EHS for any issues or filter replacements.
- NB Updating safety and evacuation protocols at SHAC the door is now card access only. Would staff call CPSO to prevent access in emergencies?
 - JH Yes, contact CPSO for access lockdowns. CPSO can also assist with a lock override button ('panic button') that can be installed near the entrance.

- Given PBOT improvement projects, be mindful of the changing sidewalk and street access issues in and around campus.

- There is a new point of access control for the West Heating Plant.
 - For access requests, contact: accessrq@pdx.edu / accessrq@pdx.edu (these are interchangeable)
- Fencing and plywood around Millar Library has been removed, but the building is not currently open to the public yet.
- Parking Structure 3 rollup gates have been repaired, increasing security. The new schedule will have the gates closed from 7 pm 6 am, requiring a badge to open them.

- VSC construction project: gating is removed, and first tenants are moving in. Larger opening celebration in late September. Authorized individuals only at this time.
- Art and Design project: will be breaking ground at Shattuck Hall parking lot soon. There will be some traffic revisions at this end
 of campus, but the pedestrian walkway at the south side of Shattuck Hall will remain open for now.
- Remember to complete Wildfire Smoke training on Canvas in case there is an incident that impacts you or the campus. This is an
 annual requirement for all employees.
 - ER Remember that there is a difference between ozone and wildfire smoke pollution. There was recently lower air quality that was due to ozone, but the EPA AirNow website and app showed a simplified average. Different types of pollution can affect people and the environment differently, and other precautions may need to be taken.
 - JR The closest monitoring station is at Lincoln High School, which provides high quality data for the campus area. Remember to switch this if you want information for other areas.
