Old Action Items and Safety Concerns

(Date reported, description of action item/safety concern, whom it was assigned to, description of follow-up, date investigated/resolved)

- What is the process for student workers to receive care given that SHAC is unable to care for on-the-job injuries?
 - Employees received notification that SHAC is unable to assess any work-related injuries, including student workers who are
 injured on the job. They must go to another healthcare facility, such as Kaiser or OHSU, that is certified to handle worker's
 compensation injuries. There are concerns that this may lead to underreporting or not addressing medical issues.
 - EH These injuries should still be reported, but it is up to the student to seek medical attention. SHAC is not certified to give medical services as part of worker's compensation, regardless of severity.
 - During employee training, she always recommends that you should be aware of where you can go for care beforehand. Many nearby health centers are certified.
 - Worker's Compensation Urgent Care Location List poster
 - All people employed by PSU may be granted emergency transportation tickets, including student workers.
 - TB Is this PSU or another organization's guideline? While this may be a conflict of interest, student employees will have less access to healthcare and may have to pay more for care.
 - EH This was a preexisting rule from SAIF that was not being enforced.
 - AK International students typically have the PSU insurance and it's particularly a concern that they will not know what to do or be excessively charged.
 - A procedure guide, FAQ, etc. would be helpful for employers to assist with this process, and for student workers to become familiar with what to do if they become injured.

Rounds / New Safety Concerns

- CQ Is reaching out again to look for more participation from other areas of campus per the map made several months ago.
- JS The skybridge from PS2 to USB is very slippery, outside and inside. There were previously rugs, but they are no longer there. The lighting is also poor at night, and some lights are out.
 - JP The rugs may have been removed for a project or cleaning, and JP will check in with custodial. Maintenance tries to preemptively add anti-slip measures on the bridges, but input from users is appreciated.
 - EH These light issues may have been noted during a recent light walk. JS will put in a work order for the lights that are out.
- TH PSU Alerts has been updated so that emergency alerts will no longer be communicated via phone calls. There will still be texts and emails sent out. Check your alert information to ensure you are subscribed to the appropriate alerts.
 - PSU Alert | Emergency Management
- JP Be cautious around slippery areas.
- NL Remember to water your Christmas tree if you have one! Dry trees can be a major flammable source.
- JH An event has been scheduled at Peter Stott for a Les Schwab event from the 26th to the 30th. Campus may be particularly busy, especially given that this is typically a quiet week.
